- › The Company acknowledges that failure to fully comply with the conditions of the permit may constitute an offence under traffic, rail safety, electrical safety and transport infrastructure legislation, and may also result in charges being applied;
- › The Company indemnifies Aurizon Network Pty Ltd and its employees or agents from all actions, suits, claims, costs and demands of every description by Aurizon Network Pty Ltd or others whatsoever arising out of or in relation to the movement by road transport as herein described;
- › The Company will provide all necessary information regarding crossings they will cross when entering and exiting mine sites, private property and unnamed/proposed roads; and
- › The Company confirms its confidence that all vehicles and trailers listed within this application can successfully traverse the proposed route without incident at any Aurizon Network Pty Ltd level crossing or bridge.
